Membership Definitions
Learn-to-Skate Membership \$20 + CFSC Membership \$400: Required for skaters participating only in the Learn to Skate program with no plans to test or compete through U.S. Figure Skating. Includes: Learn to Skate USA membership & CFSC Membership. .
Adult U.S. Figure Skating First-Time Registration \$50 + CFSC Membership \$400: Required for adults (18+) purchasing a Full U.S. Figure Skating Membership for the first-time. Includes: Adult full U.S. Figure Skating membership & CFSC Membership.
Youth U.S. Figure Skating First-Time Registration \$100 + CFSC Membership \$400: Required for skaters under 18 purchasing a full U.S. Figure Skating Membership for the first-time. Includes Youth U.S. Figure Skating membership, CFSC membership & one adult U.S. Figure Skating Membership.
Adult U.S. Figure Skating Membership \$100 + CFSC Membership \$400: Required for adults (18+) renewing a full U.S. Figure Skating membership. Included: Adult full U.S. Figure Skating membership + CFSC membership.
Youth U.S. Figure Skating Membership \$130 + CFSC Membership \$400: Required for skaters under 18 who are renewing full U.S. Figure Skating membership. Includes: Youth full U.S. Figure Skating membership, CFSC membership & one adult U.S. Figure Skating membership.
CFSC Membership (No ice) \$100: For skaters who need to maintain Casper Figure Skating Club affiliation for competition but do not require club ice. Does not include ice time, coaching, senior voting rights. May include: solo in annual show if available spot.
CFSC (additional) voting member (optional) \$40 : Provides an additional adult (18+) with CFSC voting privileges.
Additional U.S. Figure Skating Family Member (residing at the same residence, non-voting) (optional) \$50: Required for each additional family member in the same household who needs a U.S. Figure Skating membership. This is a non-voting family membership for CFSC.
CFSC Volunteer Requirement Opt-Out \$300: CFSC families are expected to complete 3 volunteer hours during the membership year. Families who choose not to volunteer may pay the opt-out fee instead.
CFSC Fundraising Requirement Opt-Out \$150: CFSC families are expected to raise a minimum of \$150 per skater, up to a maximum of \$300 per family, through the club's annual fundraising activities. Families who choose not to participate in fundraising may instead pay the fundraising buyout of \$150 per skater, up to a maximum of \$300 per family.
Additional Household Membership Discount \$25: A \$25 discount is applied to each additional CFSC membership with ice.

Casper Figure Skating Club Requirements

All CFSC Memberships with Ice include annual club dues and are subject to the following family requirements:

Fundraising Requirement: Each skater is required to raise a minimum of **\$150** through the club's annual fundraising efforts. Families with multiple skaters are capped at **\$300** in total fundraising. Families who choose not to participate in fundraising may instead pay the equivalent **fundraising buyout**, also capped at **\$300 per family**. Any unmet fundraising balance due on **January 12, 2027** will be billed to the member account at the conclusion of the fundraising period.

Volunteer Requirement: Each family must complete **3 volunteer hours** during the club year or pay the **\$300 volunteer buyout fee**. Board members satisfy the annual volunteer requirement through their Board service.

Payment Deadline: U.S. Figure Skating fees and CFSC membership dues must be paid in full by **November 10, 2026**, unless an alternate payment plan has been approved by the CFSC Board of Directors and is being followed. Members who have not met their financial obligations may not participate in club ice or other membership benefits until their account is brought into compliance.

Medical Consent and Authorization

Release of Liability, Assumption of Risk, and Indemnification Agreement

Casper Figure Skating Club (CFSC)

Please read this document carefully before signing. By signing this Agreement, you acknowledge that you have read, understand, and voluntarily agree to its terms.

1. Acknowledgment of Risk

I understand that participation in figure skating and related activities involves inherent risks that cannot be eliminated regardless of the care taken by the Casper Figure Skating Club ("CFSC"), its Board of Directors, volunteers, coaches, officials, members, or affiliated facilities.

These risks include, but are not limited to:

- Falls on or off the ice;
- Collisions with other skaters, coaches, volunteers, or objects;
- Injuries caused by skate blades or other equipment;
- Ice conditions or facility hazards;
- Equipment malfunction or failure;
- Physical exertion, illness, or medical emergencies; and
- Other known and unforeseen risks associated with participation in figure skating, club activities, exhibitions, competitions, practices, fundraising events, travel, and related activities.

I understand that these risks may result in serious injury, permanent disability, illness, property damage, or death.

2. Assumption of Risk

I knowingly and voluntarily assume all risks, both known and unknown, associated with participation in CFSC activities. I accept full responsibility for my own actions, or for the actions of my minor child, while participating in club-sponsored activities.

I certify that I (or my child) am physically able to participate in figure skating and related activities and understand that participation is voluntary.

3. Release and Waiver of Liability

To the fullest extent permitted by Wyoming law, I hereby release, waive, discharge, and covenant not to sue the Casper Figure Skating Club, its Board of Directors, officers, committee members, volunteers, coaches, officials, members, representatives, agents, sponsors, and any facility used for CFSC activities (collectively, the "Released Parties") from any and all claims, demands, causes of action, damages, losses, or liability arising out of or related to participation in CFSC activities, including those resulting from ordinary negligence.

This release does not apply to claims arising from gross negligence, reckless conduct, or intentional misconduct where such claims cannot legally be waived.

4. Indemnification

I agree to indemnify, defend, and hold harmless the Released Parties from and against any claims, liabilities, damages, losses, costs, or expenses, including reasonable attorney's fees, arising from my actions or the actions of my minor child while participating in CFSC activities, to the extent permitted by applicable law.

5. Medical Responsibility

I understand that CFSC does not provide medical or accident insurance for participants.

I acknowledge that I am financially responsible for any medical expenses incurred as a result of participation in CFSC activities. I further understand that emergency medical treatment is addressed separately in the CFSC Medical Consent and Authorization form.

6. Compliance with Club Policies

I agree to comply with all CFSC policies, rules, safety requirements, and the Parent/Guardian and Skater Code of Conduct. Failure to comply with club policies may result in disciplinary action, including suspension or termination of membership, in accordance with CFSC policies.

7. Severability

If any provision of this Agreement is determined to be invalid or unenforceable, the remaining provisions shall remain in full force and effect.

Acknowledgment

I have carefully read and understand this Release of Liability, Assumption of Risk, and Indemnification Agreement. I understand that I am giving up certain legal rights by signing this agreement, including the right to bring certain legal claims against the Casper Figure Skating Club and other released parties. I sign this agreement voluntarily and intend it to be legally binding to the fullest extent permitted by law.
